The existing land use of the areas affected by the construction of the proposed roads is first and second rotation non native conifer forest intended for timber production. No site lies within a designated site however the River Oykel SSSI and SAC could potentially be affected by forest operations.

Description of Likely Significant Effects

The most likely significant effect on the nearby designated freshwater habitats will be positive. Harvesting extraction distances will be significantly reduced, leading to less likelihood of soil erosion and diffuse or point source pollution. Run - off from forest roads drainage will be carefully managed into settlement ponds. Watercourse crossings will be bridged with higher specification materials rather than forwarder built temporary log bridges.
